Bill to Defend Immigrant Rights and Oppose HR 4437

Authored and Sponsored by Senator Yvette Felarca

- Whereas: The ASUC has a strong history of defending the rights of immigrants, documented and undocumented,
- Whereas: The Senate voted last year to endorse a statewide civil rights march called to end a series of INS raids and deportations in Southern California that was being waged against Latino communities.
- Whereas: Congressional Bill HR4437 is an inherently discriminatory bill which has passed the House of Representatives. The US Senate is scheduled to vote on it next. If passed the Congressional Bill HR4437 would:
- criminalize as felons undocumented immigrants and service providers who assist them. It would classify 11 million undocumented immigrants working in the U.S. as aggravated felons, subjecting them to deportation and imprisonment and depriving them of any access to a hearing prior to deportation
 - require day laborer centers to check immigration papers.
 - require local law enforcement to work as federal Immigration agents.
 - eliminate birthright citizenship for children born in the U.S. to undocumented immigrants.

Therefore, let it be resolved that:

The ASUC is on record in strong opposition to HR4437. The President of the ASUC shall send a letter to our California Congress people with a copy of this motion, and urge them to oppose this discriminatory bill.

A Bill in Support ASUC Sponsorship Renewal for Cal in the Capital

WHEREAS, Cal in the Capital has been a student group on the UC Berkeley campus for over forty years; and

WHEREAS, Cal in the Capital was previously sponsored by the ASUC, and appears on the 2002 Spring Budget as a 30-year ASUC-sponsored Student Activities Group; and

WHEREAS, Cal in the Capital received approximately \$12,000 (twelve thousand dollars) in 2002 from the ASUC; and

WHEREAS, Cal in the Capital came to the ASUC to seek sponsorship in Fall 2005, receiving 1st-year SAG status and \$150 (one hundred fifty dollars); and

WHEREAS, the ASUC Senate has the authority to renew sponsorship of any student group for a decided number of years based on the group's historically recorded relationship with the ASUC; and

WHEREAS, Cal in the Capital assists students with internships in Washington D.C., this year promising 85 (eighty-five) spots to eligible and qualified candidates from UC Berkeley.

THEREFORE BE IT RESOLVED, that the ASUC recognize Cal in the Capital as a 31-year (thirty-one year) ASUC-sponsored Student Activities Group (SAG) for the 2005-06 academic year.

XX. A Bill In Support of AFSCME Housing and Dining Employees

Authored by Husain Misherghi

Sponsored by Senator Vishal K Gupta

- WHEREAS,** The University of California Housing/Dining Services have failed to provide living wages to custodians
- WHEREAS,** Custodians are paid \$18.89 starting wage at Chabot-Las Positas Community college in Hayward while their counterparts at UC Berkeley receive only \$10.70
- WHEREAS,** The estimated student-budget for the 2005-2006 school year (8-9 months) to live on-campus was \$23,232
- WHEREAS,** New custodians are paid \$22,256 annually and many of them support dependents
- WHEREAS,** Custodians at Chabot-Las Positas and Peralta Community Colleges receive wage set increases after 6 months, 1.5 years, 2.5 years, and 3.5 years of employment and UC Berkeley custodians have no such consistency but the same need for wage increases
- WHEREAS,** The Housing & Dining Executive Director and the Housing Facilities and Operations Director have not been returning phone calls and emails
- WHEREAS,** Last fiscal year the university system quietly awarded employees \$871 million in various forms of hidden compensation on top of their salaries and overtime and do have the means to increase custodian wages
- WHEREAS,** Custodians are an integral part of UC Berkeley's community and work very hard to contribute to the maintenance of the University and enable it to continually function and perform as the top public university in the Nation
- WHEREAS,** AFSCME 3299 Union has continually sought to bargain with the University for fair and equitable wages, yet faced increased opposition
- WHEREAS,** Custodians should not have to bargain for a living wage, which is a labor right
- WHEREAS,** Custodians have innate and inalienable rights to a dignified life, to fair and equitable wages, and respect from their employers; all of which have been denied by UC Berkeley
- WHEREAS,** Currently the University of California shamelessly continues to exploit workers and continues illegal labor practices

THEREFORE, BE IT RESOLVED,

That The Associated Students of the University of California support AFSCME 3299 in their efforts to end poverty wages and live a dignified life.

BE IT RESOLVED,

That The Associated Students of the University of California establish an active committee with at least 4 senate members to educate the student body about these illegal labor practices

BE IT RESOLVED,

That The Associated Students of the University of California actively advocate for justice to UC Berkeley's custodians through a joint committee of workers and students, comprising of at least 4 senate members and 1 executive president. This committee will serve to advocate with workers through various measures to achieve justice

BE IT RESOLVED,

That The Associated Students of the University of California draft and send a letter to Housing and Dining to arrange a meeting, where senators and the executive office presidents attend along with workers, to discuss a just and fair contract and wages for custodians

BE IT FURTHER RESOLVED,

That given the urgency of poverty wages to our custodians and the continuing injustices, that The Associated Students of the University of California commence action on these resolutions this month, March 2006, and immediately act in solidarity with custodians of UC Berkeley.

A Bill In Support of Southeast Asian Student Coalition Summer Institute (SASC-SI)

- WHEREAS,** Fiat Pax is involved in the UC Nuclear-Free Campaign and the Anti-Recruitment Campaign; and
- WHEREAS,** Fiat Pax has just become and OSL student group; and
- WHEREAS,** the Fiat Pax budget for 2005-2006 is as follows:

- WHEREAS**, the Korean Student Association was granted an amount of only \$2,660.00 even after having been sponsored for 25 years, while two to three other student groups that have been sponsored for less than 20 years by the ASUC and also put on annual culture shows have received about \$1,800.00 to \$7,400.00 more during the budgeting allocation last spring; and
- WHEREAS**, due to this low grant, it is in desperate need for more funding; and
- WHEREAS**, the budget will be submitted at the Finance Committee meeting; and therefore be it
- RESOLVED**, that the ASUC recognize the 2006 KSA Culture Show as an ASUC Sponsored event; and be it further
- RESOLVED**, that the ASUC shall allocate \$1500 (One thousand five hundred dollars) from the Senate Contingency Fund to help cover the cost of this significant event; and be it further
- RESOLVED**, that the ASUC advertise the 2006 KSA Culture Show for free in the student government page in the *Daily Californian* the week of the show (the week of April 24th to 28th).

**XXV. A Bill In Support of a Democratic Referendum for a
XXVI. Recreational Sports Fee**

WHEREAS, the Recreational Sports Facility is currently operating under a financial model in which the majority of its revenue is generated by user fees of students who subscribe for RSF membership; and

WHEREAS, this current financial model is untenable unless user fees are increased to a degree that makes the RSF unaffordable for many students; and

WHEREAS, significant increases in the Recreational Sports Facility membership fee have become a burden upon students, reaching \$65 this semester, with guaranteed increases up to \$95 in the near future under Recreational Sports current financial model; and

WHEREAS, due to financial constraints, the RSF can no longer offer waivers for Pell Grant students, who are among those students with the most financial need, and there is no current means of financial aid for those students who wish to use the RSF; and

WHEREAS, a financial model in which revenue is driven by a mandatory student fee rather than by user fees is the model used at every other university in the UC system and would allow for a lower cost of access to the RSF for a given user; and

WHEREAS, a mandatory student fee for the RSF is a proposed solution to the financial problems faced by Recreational Sports that would allow those students who have financial need to get the majority of the RSF cost covered by financial aid.

THEREFORE BE IT RESOLVED, that the following language be placed as a referendum on the Spring 2006 ASUC electoral ballot:

RECREATIONAL SPORTS FEE REFERENDUM
Final Language

To reduce the cost of membership to the Recreational Sports Facility (RSF) and allow students with financial need to acquire assistance for RSF membership, do you approve of a mandatory fee to support Recreational Sports?

The purpose of this new RSF fee is to reduce the cost of student membership fees and allow the fee to be incorporated in student financial aid need assessments. The fee is in addition to that portion of the Berkeley Campus Fee (\$28.50 per semester) dedicated to paying for the original construction of the RSF. Students wishing to use the RSF will continue to be required to purchase student memberships.

If the RSF fee is approved, the following changes will occur at the RSF:

- The membership fee will drop from the current \$65.00 per semester to \$10.00 per semester and remain at that level beginning in Fall Semester 2007 and continuing for a period of ten years, through Spring Semester 2016.
- The cost of a student membership for summer 2006 will be \$45.00. Beginning in summer 2007, the student membership fee will be \$10.00, the same amount as the regular semester student membership fee.
- The RSF will stay open for an additional 10 hours each week, that is, until midnight Sunday through Thursday and until 11:00 p.m. on Friday and Saturday during Fall and Spring semesters.

The fee will apply to all registered graduate and undergraduate students, and will be governed by the University's standard schedule of refunds. The fee is subject to the following costs and conditions:

- Collection of the fee will begin with Fall Semester 2006 at \$40.00 per semester and continue for three years, through Spring Semester 2009, at the same rate. Students registering in the summer will be assessed a fee in the same amount as the following fall semester, beginning with summer 2007.
- After Spring 2009, the fee will increase every three years to cover the cost of inflation and other increases (including the cost of energy) in the following manner:
 - 2006-07, 2007-08, and 2008-09 (Years 1-3): \$40.00 per semester
 - 2009-10, 2010-11, and 2011-12 (Years 4-6): \$45.00 per semester
 - 2012-13, 2013-14, and 2014-15 (Years 7-9): \$50.00 per semester
 - 2015-16 (Year 10): \$55.00 per semester
- An election to reauthorize the Fee will be held during the next available ASUC election if any of the following conditions occur:
 1. The level of Registration Fee funds to support Recreational Sports is reduced from its current level of \$630,000 per year;
 2. Recreational Sports is not treated comparably with other Registration Fee-funded units with respect to changes in Registration Fee levels or income; or
 3. A majority of the student members of the Recreational Sports Advisory Board and a majority of the ASUC Senate conclude that the RSF has not been responsive to the needs of the student body during the previous academic year
- If the Fee is not reauthorized (i.e., passed by a majority with 20% of the student body voting), then the Fee will be revoked, resulting in the reinstatement of higher Recreational Sports membership fees.

- Before the fee expires in Spring 2016, a new RSF fee election will need to be held to continue to offer an RSF membership that is affordable to most students.

In accordance with campus policy, one-third of the Fee will be returned to financial aid to help offset the cost of this Fee for students who are eligible for financial aid.

WHEREAS, The Associated Students of the University of California (ASUC) is the official voice of all students at the University of California, Berkeley; speaking for the general interests of all students on campus; and

WHEREAS, The Graduate Assembly (GA) is the official voice of graduate and professional students at the University of California, Berkeley, speaking for the specific interests of graduate and professional students on campus; and

WHEREAS, It is for the benefit of the ASUC and the GA to work together for the improvement of student life on campus; and

WHEREAS, The benefits of working together have brought about great benefits this year, exemplified by the progress made on the issue of lower Sproul redevelopment and on fighting unnecessary student fees; and

WHEREAS, the best way to ensure such cooperation is an equitable relationship between the ASUC and the GA codified in formal documents; and

WHEREAS, the attached MOU has been the result of hard work and negotiation by members of the ASUC and the GA; and

THEREFORE BE IT RESOLVED, that the ASUC Senate assent to the constitutional amendment attached hereto as Attachment A, and incorporated by reference, modifying Article IV of the ASUC Constitution.

BE IT FURTHER RESOLVED, that the Constitutional amendment so referenced in the above clause be placed before the student electorate in the Spring 2006 ASUC Election.

BE IT FURTHER RESOLVED, that the ASUC Senate assent to the Memorandum of Understanding attached hereto as Attachment B, and incorporated by reference, between the ASUC and the GA.

BE IT FURTHER RESOLVED, that assent to the ASUC Senate to the Memorandum of Understanding contained in Attachment B, be conditioned on acceptance by the Graduate Assembly of the same Memorandum of Understanding.

BE IT FINALLY RESOLVED, that all appropriate changes to the ASUC Bylaws will be made by the ASUC Senate upon ratification by the ASUC, the Graduate Assembly, and all appropriate constitutional amendments.

Attachment A

ARTICLE IV - JUDICIAL COUNCIL

SECTION 2: MEMBERSHIP

- A. The Judicial Council shall consist of nine (9) students, nominated by the President. The nominations of the President will then be interviewed by the Constitutional Review Committee of the Senate. The President may nominate any number of individuals to the Judicial Council positions, yet he/she may not nominate fewer than three individuals per available position on the Judicial Council. Following the interviews of the prospective Judicial Council members, Constitutional Review Committee will vote to select the nominees to be sent to the Senate for approval.
- B. Members shall have a term of two (2) years, reckoned from the date on which they are confirmed.
- C. In the event that the President fails to submit at least three nominations to the Senate within three (3) regular Senate meetings following the occurrence of a vacancy, nominations may be made by any executive officer or Senator. If a Presidential nomination is rejected, the President shall have one (1) regular meeting to introduce another nomination before right of nomination devolves to other executive officers and Senators. If the Senate does not consider a nomination to fill a vacancy within two (2) regular meetings after submission of the nomination, then the Senate must consider the nomination before any further business.

ARTICLE IV - JUDICIAL COUNCIL (Revisions)

SECTION 2: MEMBERSHIP

- A. The Judicial Council shall consist of nine (9) students, six of which shall be nominated by the President. The nominations of the President will then be interviewed by the Constitutional Review Committee of the Senate. The President may nominate any number of individuals to the Judicial Council positions, yet he/she may not nominate fewer than three individuals per available position on the Judicial Council. Following the interviews of the prospective Judicial Council members, Constitutional Review Committee will vote to select the nominees to be sent to the Senate for approval.
- B. Members shall have a term of two (2) years, reckoned from the date on which they are confirmed.
- C. In the event that the President fails to submit at least three nominations to the Senate within three (3) regular Senate meetings following the occurrence of a vacancy, nominations may be made by any executive officer or Senator. If a Presidential nomination is rejected, the President shall have one (1) regular meeting to introduce another nomination before right of nomination devolves to other executive officers and Senators. If the Senate does not consider a nomination to fill a vacancy within two (2) regular meetings after submission of the nomination, then the Senate must consider the nomination before any further business.
- D. Three of the students in the Judicial Council shall be nominated by the GA President. Upon receipt of a vacancy in one of these three seats, the GA President will have two Graduate Assembly meetings to submit no fewer than three nominations for each vacancy. The Graduate Assembly will then forward three of the nominees to be confirmed by the senate. If the GA President does not make nominations within two Graduate Assembly meetings, right of nomination goes back to the ASUC President.

**Memorandum of Understanding between the Associated Students
of the University of California and the Graduate Assembly**

This Memorandum of Understanding is entered into between the Associated Students of the University of California ("ASUC") and the Graduate Assembly of the University of California, Berkeley ("GA") to modify the relationship of the Graduate Assembly to the ASUC. This Memorandum supercedes and renders null all previous Memoranda of Understanding between the ASUC and the Graduate Assembly. This document becomes effective upon ratification of the GA delegates, the ASUC senate, and all appropriate constitutional amendments.

NOW THEREFORE, in recognition of their mutual promises and the consideration made herein, the ASUC and the Graduate Assembly agree as follows:

I. Recognition and Status

- A. Pursuant to the ASUC Constitution, the Graduate Assembly recognizes the authority of the ASUC to speak for common interests of the student body as a whole at the University of California, Berkeley in fora both inside and outside the campus.
- B. Pursuant to the ASUC Constitution, the ASUC recognizes the authority of the Graduate Assembly to speak for the specific interests of graduate and professional students at the University of California, Berkeley both inside and outside the campus.
- C. The Graduate Assembly, with a majority vote, shall have the right to void any ASUC legislation that speaks for the whole student body within two general Graduate Assembly meetings. This right shall only be granted for External bills.
- D. When the Graduate Assembly seeks to speak for all students at the University of California, Berkeley, the President of the Graduate Assembly shall offer its position to the ASUC Senate as a main motion.
- E. The Graduate Assembly shall transmit or make available to the Executive Officers of the ASUC the agenda and minutes of all Graduate Assembly meetings as they become available by means of electronic mail.
- F. The ASUC shall transmit or make available to the executive officers of the Graduate Assembly the agenda and minutes of all Senate meetings, executive orders and presidential vetoes, and Judicial Council decisions as they become available by electronic mail.

II. Finance

- A. The ASUC shall automatically appropriate to the Graduate Assembly each year the total amount of mandatory student fees paid by graduate and professional students to the ASUC minus the total amount of Graduate Student Return to Aid.

- B. The Senate shall not affect a modification in Graduate Assembly expenditures, divert revenue, or withhold funds except in times of Fiscal Emergency (a Section 5, Article VI of the ASUC Constitution), and shall respect total Graduate Assembly authority over its finances except where the tax-exempt status of the ASUC is in danger.
- C. In times of Fiscal Emergency and if the association wishes to make changes in the financial arrangement involving the Graduate Assembly, a committee shall immediately convene composed of the following: the ASUC President, the GA President, the ASUC Executive Vice President, the ASUC Finance Officer, the GA Finance Chair, the GA Organ and Rules Chair, and the ASUC Executive Director (non-voting).

III. Representation

- A. The Graduate Assembly shall make and confirm all appointments designated for graduate and professional students to academic, campus, or system-wide committees. The Senate shall not subject such appointments to confirmation or denial
- B. The Graduate Assembly shall nominate the graduate student members of the ASUC Store Operations Board. The Senate shall deem the nominees confirmed on receipt of the nomination.
- C. The Graduate Assembly shall be entitled to representation and the right to address the general body of the academic senate.

IV. Resources

The ASUC recognizes the Graduate Assembly's sole authority to occupy and use Anthony Hall. In extreme cases where Anthony Hall cannot be occupied, the ASUC will recognize the right of the Graduate Assembly to occupy and use some substitute space.

V. ASUC Elections

- A. The ASUC relinquishes all claims to Graduate Assembly payment for elections costs before the 2002-2003 academic year.
- B. For the 2002-2003 year, the Graduate Assembly is responsible for paying \$18, 997, the remaining balance of election costs for the 2003 Spring ASUC election.
- C. For the 2003-2004 year, the Graduate Assembly is responsible for paying \$6,789, the remaining balance of the election costs for the 2004 Spring ASUC election.
- D. For the 2004-2005 year, the Graduate Assembly is responsible for paying a percentage of the total election costs for the Spring 2005 ASUC Election, which shall be calculate by the following formula: the average between the proportion of graduate students to undergraduates in the total student population and the percentage of voters registered as graduate students.
- E. For future academic years, the Graduate Assembly will pay either 12% of total election costs or a percentage of election costs equal to the percentage of voters in the Spring ASUC election who are registered graduate students, whichever of the two is greater.

- F. Each year, the Graduate Assembly shall budget a sum sufficient to cover the base elections costs of the Graduate Assembly for that year based on the base election cost for the prior year. The Graduate Assembly shall be responsible for paying its share of the elections costs for an overall ASUC Election budget of up to \$60,000.
- G. If additional funding is required for ASUC Elections beyond \$60,000, then a committee composed of the ASUC President, the GA President, the Chair of the GA Finance Committee, and the Chair of the ASUC Finance Committee shall convene. Any agreement coming out of these meetings shall pend approval of the ASUC Senate.
- H. The ASUC Selection Committee for the Elections Council Chair shall be comprised of 6 members, 1/3 of which shall be graduate students. Preference will be given to Graduate Students serving in the ASUC Senate followed by GA Delegates. The remaining members of this committee shall be from the ASUC Senate. In addition, there shall be one position on the council with the designation Graduate Outreach Coordinator.

VI. Conflict Resolution

- A. Three of the students in the Judicial Council shall be nominated by the GA President. Upon receipt of a vacancy in one of these three seats, the GA President will have two Graduate Assembly meetings to submit no fewer than three nominations for each vacancy. The Graduate Assembly will then forward three of the nominees to be confirmed by the senate. If the GA President does not make nominations within two Graduate Assembly meetings, right of nomination goes back to the ASUC President.
- B. The Judicial Council must make it a priority to change its JRP's to better serve Graduate Students in cases dealing with the Graduate Assembly. These changes must be done in such a way as to grant an opportunity for equal representation of Graduate justices and Undergraduate justices in all cases dealing with the Graduate Assembly.
- C. All powers not specifically mentioned here are retained by the ASUC senate.

WHEREAS, the Student Advocate's Office does not have enough funding to make necessary long-term publicity investments such as printing said brochures, and investing in new pens; and

WHEREAS, these long-term investments have, in the past, lasted at least three and a half years, and have been very effective in promoting the Student Advocate's Office's professional image & services; and

WHEREAS, the Student Advocate's Office's senior staff has already agreed to contribute some of its stipend to said outreach efforts; and

WHEREAS, total expenditures on these investments will still exceed SAO's budget by \$3000;

THEREFORE BE IT RESOLVED, that the ASUC shall allocate \$2500 (two thousand five hundred dollars) from the Senate Contingency Fund to the Student Advocate's Office.

WHEREAS, there is a degree of social responsibility which must be considered and the negative repercussions of incorrect portrayals and irresponsible publications erode at efforts of dialogue and improved relations between various groups

WHEREAS, freedom of expression is one of our most valued rights however we also hold the freedom of expression to stand against dogmatic bigotry and racist statements which fuel unfounded hatred and intolerance.

THEREFORE BE IT RESOLVED, that the ASUC condemn the recent insensitive re-publication of the cartoons of the Prophet Muhammad for inciting religious hatred and for its promotion of bigotry on campus

BE IT FURTHER RESOLVED, that the ASUC stand in solidarity with religious groups that have been victimized or marginalized by bigoted, hateful and intolerant actions.
