**A Bill in Support of Oakland Kicks Asthma**

- WHEREAS,** Oakland is the largest city in the Alameda County with a large proportion of children living in poverty; and
- WHEREAS,** Alameda County has notoriously poor air quality, inadequate housing, and low access to care; and
- WHEREAS,** these problems in conjunction with others contribute to Oakland's high rates of asthma and the California Department of Health Services identified Alameda County as having the second highest rate of asthma hospitalizations for children and early teens among all counties in the state; and
- WHEREAS,** within Alameda County the highest rates are found in Oakland; and
- WHEREAS,** Oakland Kicks Asthma is an organization which employs an innovative school-based asthma education curriculum designed to help elementary school children manage their asthma so they spend more time in the classroom and less time in the emergency room; and
- WHEREAS,** Oakland Kicks Asthma's goal is to provide their curriculum (Open Airways for Schools) to elementary schools within their target area, the East Bay; and
- WHEREAS,** Oakland Kicks Asthma utilizes bi-lingual and culturally sensitive materials which enable them to reach a broad spectrum of children and their families; and
- WHEREAS,** Oakland Kicks Asthma is an intervention program of the American Lung Association of the East Bay for indigent youth with asthma, which provides training for college students to be able to teach the curriculum; and
- WHEREAS,** Oakland Kicks Asthma works closely with partners from the University of California Berkeley School of Public Health, Oakland Unified School District, and Children's Hospital Oakland; and
- WHEREAS,** In the past year Oakland Kicks Asthma has outreached to over 15 elementary schools in the Bay Area and has gained approval and sponsorship of Dr. Ira Tager, Professor of Epidemiology under UC Berkeley's Department of Public Health; and

**THEREFORE BE IT RESOLVED**, that Oakland Kicks Asthma be recognized as a first-year Student Initiated Service Group.

**WHEREAS,** Suicide Awareness Week had a number of events, including a screening of the movie "The Bridge" followed by a discussion about suicide, stigma, and the media, a charity poker tournament to raise money for Crisis Support Services of Alameda County, and the distribution of information cards and wristbands on Sproul all week; and

**WHEREAS**, Dil Se's next event is UC Berkeley's national competition, Anahat, and they require funding for costumes and props;

**WHEREAS**, the budget is as follows:

**THEREFORE BE IT RESOLVED**, that the ASUC recognize Dil Se as a first year ASUC Student Activity Group (SAG); and

**LET IT BE FURTHER RESOLVED**, that the ASUC shall allocate \$150 (one hundred fifty dollars) from the Senate Contingency fund to sponsor Dil Se and their competition at UC Berkeley's Anahat

**A Bill in Support of Improving ASUC Budget Transparency and Communication**

WHEREAS, Transparency is vital to the improvement of services and integrity of operations in any government, non-profit, educational or business organization.

THEREFORE IT BE RESOLVED THAT, the ASUC Senate request that the ASUC Auxiliary provide all ASUC officials with quarterly budget reports, and at least an annual budget report that includes:

- detailed operational expenses, which include line items more specific than “program supplies,” “general supplies,” and “miscellaneous expenses”
- a thorough breakdown of all the revenue from the ASUC’s commercial services agreements, including the Bears’s Lair, MLK and ASUC Mall

THEREFORE IT BE FURTHER RESOLVED THAT, The ASUC will not support plans to have a Panda Express on the UC Berkeley campus until it is provided with detailed ASUC Auxiliary Budgets, in order to better understand the financial situation of the ASUC and how Panda Express would affect it. In the meantime, the Senate shall support the Store Operations Board in finding alternative food vendors that are both environmentally and financially sustainable for Lower Sproul.

**A Bill in Support of Berkeley Art Museum/ Pacific Film Archive Student Committee**

**WHEREAS**, the BAM/PFA Student Committee connects the student body to the cultural resources offered by the Berkeley Art Museum and the Pacific Film Archives; and

**WHEREAS**, the BAM/PFA Student Committee creates student-specific spaces that cultivates interests in the arts and film, inspiring dialogue amongst students; and

**WHEREAS**, this organization produces events that connect students with current art exhibitions, new media, the Bay Area art professional community and the on-campus creative community; and

**WHEREAS**, this committee is comprised of a Museum staff advisor and 16 undergraduates of every year from a diverse collection of majors (including Neurobiology, Economics, Mass Communications, History of Art, Architecture, Spanish, and Business); and

**WHEREAS**, their members organize 6 events a year: (2) exhibit opening parties, an arts fest, special film screening, career forum, interactive social with art, and the foundation of a film community attracting 350 students for smaller events to over 700 for larger venues; and

**WHEREAS**, the student group has increased the Berkeley Art Museum's attendance by 200%; and

**WHEREAS**, the Student Committee has encouraged first visits to the Museum, provided a way for students to meet face to face with Bay Area professionals, brought artists to speak to students, exposed students to the Pacific Film Archive and stimulated interest in the unconventionality of Cal's own Museum and Film Archive and will do so for more futures in the coming years; and

**WHEREAS**, the Committee has never asked for any ASUC funding for previous service events; and

**WHEREAS**, the Committee faced a last-minute budget cut from the Museum, working with \$4150 less than planned; and

**WHEREAS**, the budget for the BAM/PFA Student Committee is as follows,

**THEREFORE BE IT RESOLVED**, that the ASUC recognizes BAM/PFA Student Committee as a first-year Student-Initiated Service Group (SISG); and

**LET IT BE FURTHER RESOLVED**, that the ASUC Senate allocate \$1,500 from the ASUC Senate Contingency Fund to the Student Committee for Berkeley Art Museum/Pacific Film Archive.

**WHEREAS,** Caliber Magazine focuses on bringing a balanced perspective on culture, society, sports, fashion, events, academics and miscellaneous topics concerned with UC Berkeley; and

**WHEREAS,** Caliber Magazine will seek to provide a general source of information that is available to students of all ages and academic concentrations; and

**WHEREAS,** Through the combination of graphic and textual elements Caliber Magazine hopes to create a magazine that best displays Berkeley student life as well as topics of interest and special events on our campus. Possible articles will be about: club activities, ASUC postings, opinion, reports, investigations, top ten lists, fashion advice and displays, musical/theatrical performance reviews, album reviews, book reviews, movie listings, food advice, shopping lists, club and restaurant reviews, class/course spotlights, dorm decorative articles, sexual advice and reports, full-blown features, jokes, college humor, and paper games; and

**WHEREAS,** Caliber is not a free magazine because a large amount of monetary support is needed to continuously produce monthly issues. The magazine will cost two dollars per issue, with certain discounts for retailers, student clubs, bulk orders, and university representatives in order to sustain the publication over time. However, the publication seeks ASUC support in getting this project started; and

**WHEREAS,** Caliber is a project created and planned for since the beginning of fall 2008 and even though the magazine hasn't been marketed on campus yet, there have already been 16 registered staff members; and

**WHEREAS,** Caliber is a very expensive project to start and maintain, mainly because of its full-color 48 page features. Below is an itemized budget required to develop and print the 1st issue:

**A Bill in Support of Replenishing the Public Service Fund**

**WHEREAS**, SB 88 created the Public Service Fund in the spring of 2008; and

**WHEREAS**, the Public Service Fund is the only grant that provides funds for students who have repeatedly demonstrated interests and enthusiasm in seeking methods to fulfill the unmet needs of outside communities; and

**WHEREAS**, public service provides students with an opportunity to make a positive impact on the world outside of Cal; and

**WHEREAS**, there is a need for humanitarian and philanthropic efforts in our society; and

**WHEREAS**, these public service efforts may require expenditures for materials, travel costs, and/or housing in order for the successful execution of their endeavors; and

**WHEREAS**, undergraduate applicants can apply for up to \$750 and graduate students can apply for up to \$250; and

**WHEREAS**, the Public Service Fund was initially allocated \$3,500 and replenished with \$8,500 later on in the semester; and

**WHEREAS**, the Public Service Fund was introduced at the first Grants Workshop for the 2008-2009 academic year on October 8th; and

**WHEREAS**, the Public Service Fund has already processed 54 applications in the fall semester;

**WHEREAS**, the Public Service Fund currently has a deficit of \$2,075 dollars

**THEREFORE BE IT RESOLVED**, that the ASUC shall allocate \$7,000 to the Public Service Fund from Carry Forward.

- WHEREAS**, every year API (Asian Pacific Islander) students from all areas of the campus and the community come together to bring underrepresented issues within our communities to the forefront; and
- WHEREAS**, the purpose of the 19<sup>th</sup> Annual Asian Pacific Islander Issues Conference (APIICON) is to create awareness of issues and ethnic diversity, as well as create dialogue within and among the API communities; and
- WHEREAS**, this year marks the 40<sup>th</sup> anniversary of the historic third world Liberation Front (twLF) Movement, which reminds us as students of color at Berkeley to remember what it means to have relevant education not only on campus, but also other college and university campuses throughout the nation; and

**Whereas**, per Title I Article 6.1 of the ASUC Bylaws, the ASUC Senate follows Robert's Rules of Order, Newly Revised; and

**Whereas**, Robert's Rules of Order only mandates for a simple majority when discussing bills, despite the financial allocation; and

**Whereas**, ASUC Constitution and Robert's Rules of order conflict in the procedure to pass amendments that include financial allocations; and

**Whereas**, The ASUC Constitution supersedes Robert's Rules of Order; and

**Whereas**, it has become dilatory to pass amendments at a simple majority but not have the bill itself pass; and

**Whereas**, Title I Article 6.4 of the ASUC Bylaws states:

**6.4 Making Motions**

1. The maker of a Motion shall have one (1) minute to obtain a second.
2. All amendments to a Main Motion must be germane to the topic of the Motion.
3. Any amendment to a Resolved clause that specifies a numerical financial amount must use Robert's Rules "Filling Blanks" procedure, from high to low.

**Therefore be it Resolved**, that Title I Article 6.4 of the ASUC Bylaws be amended to include the following text as italicized below:

**6.4 Making Motions**

1. The maker of a Motion shall have one (1) minute to obtain a second.
2. All amendments to a Main Motion must be germane to the topic of the Motion.
3. Any amendment to a Resolved clause that specifies a numerical financial amount must use Robert's Rules "Filling Blanks" procedure, from high to low.
4. *Any amendment to a Resolved clause that specifies a numerical financial amount must be approved by 2/3 majority of the entire senate.*

**WHEREAS,** The mission statement of the Southeast Asian Student Coalition (SASC) is to unite Southeast Asian communities, particularly those bounded by the historical context of the Viet Nam War, and to address the social injustices, the economic inequalities, and political under-representation that they face; and

**WHEREAS,** Because Southeast Asian students have been historically underrepresented in higher education, SASC Summer Institute strives to address this issue by introducing high school students to the higher education experience and connecting them to resources and information that will help them navigate through the college application process; and

**WHEREAS,** SASC Summer Institute is a one week program that will take place from June 23<sup>rd</sup> to June 28<sup>th</sup>, 2009; and

**WHEREAS,** Approximately 45 students from throughout California and out of state come to UC Berkeley to engage in workshops and teach-ins about higher education, cultural and political awareness, and historical and contemporary community issues; and

**WHEREAS,** “Issues” facing the Southeast Asian communities include, but are not limited to, underrepresentation in higher education that is, the criminalization and deportation of Cambodian and Vietnamese refugee communities, youth, gang, and domestic violence, inter- and intra-Ethnic funk, escalating incarceration rates, limited job-access, generational misunderstandings, Post Traumatic Stress Disorder and other health related problems; and

**WHEREAS,** SASC Summer Institute provides high school students with the opportunities to reexamine their family backgrounds, explore their his/her-story and culture, and connect their knowledge to their actions by being critical about the issues that still exist in their communities and offer them the tools to address and react to these “issues”; and

**WHEREAS,** Southeast Asian communities make up one-third of the Asian Pacific Islander population, they make up only less than 1% of college campuses across the nation, with their actual numbers not known due to un-comprehensive demographic data collection on behalf of universities; and

**WHEREAS,** SASC Summer Institute’s main objectives is to encourage high school youth to pursue higher education, promote self-empowerment through cultural awareness, create cross cultural coalitions, build networks between high school students, college students, parents, and community members to promote improved access to college education for Southeast Asian

youth, and increase the number of Southeast Asian students on the UC Berkeley campus in the future; and

**WHEREAS**, SASC Summer Institute outreaches to high school students from diverse ethnic, regional, academic, socio-economic, gender, and family backgrounds as a way to create a safe space where students can share their unique experiences and expand their understanding of the Southeast Asian his/her-story, identity, and struggle; and

**WHEREAS**, SASC Summer Institute 2009 will mark the 8<sup>th</sup> consecutive year that Summer Institute has been around;

**WHEREAS**, the Southeast Asian Student Coalition is currently trying to put a database together of past SASC mentees to show how the program has impacted their lives;

**WHEREAS**, every summer, high number of past mentees volunteer a week of their summer to and help with the program;

**WHEREAS**, 11.4% of the Cambodian community holds a Bachelors Degree or higher  
9.4% of the Laotian community holds a Bachelors Degree or higher  
20.2% of the Vietnamese community holds a Bachelors Degree or higher  
compared to the U.S. National Average of 28.8%

**WHEREAS**, 31.8 % of the Cambodian community live in linguistic isolation  
35.1% of the Hmong community lives in linguistic isolation  
31.8% of the Laotian community lives in linguistic isolation  
45% of the Vietnamese community lives in linguistic isolation

**WHEREAS**, at last check the average per capita income for the  
Cambodian community was at \$10,215  
for the Hmong community, \$6,613

The classroom equipment is used primarily for workshop curriculum such as slide shows and videos pertaining to the Southeast Asian history and culture.*

**WHEREAS**, UC Berkeley's Alpha Beta Chapter of Sigma Chi currently holds the most members, seventy six (76), on the Berkeley campus and received the Christopher J Wootten Outstanding Fraternity Scholarship Program Award at the 2008 Greek Awards along with the Award for Chapter Advisor of the Year; and

**WHEREAS**, The week-long philanthropic events involve a dozen other chapters on campus in a unifying effort promoting community service at UC Berkeley and raising needed funds for the Oakland Children's Hospital and the Huntsman Cancer Institute; and

**WHEREAS**, One-third of the Huntsman Cancer Institute's funding for cancer research, treatment, and educational programs comes from donations made to the Huntsman Cancer Foundation by individuals, small groups, and businesses; and

**WHEREAS**, In 2007, the Sigma Chi Fraternity raised and donated over eight thousand dollars, and in 2008, over fourteen thousand dollars, demonstrating considerable growth in its contribution to philanthropic causes; and
